Champions League holder PSG will play Bayern Munich and Barcelona in this season's league phase while record 15-time winner Real Madrid will face Manchester City and Liverpool after Thursday's draw set up some blockbuster encounters.

PSG will also meet Tottenham Hotspur and New-

castle United along with Atalanta and Bayer Leverkusen in the new league format which started last season, where each club plays eight games - four at home and four away

The league phase gets underway with the 36 teams playing on eight matchdays between September 16 and January 28. The knockout phase begins in February while the final will be played on May 30 in Budapest.


